

Paw Points® December Instant Win Game

Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Paw Points® December Instant Win Game (the "Instant Win Game") is open only to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old and members of the Fresh Step® Paw Points® Rewards Program at the time of entry.
